Defining terms

- Human rights
 - Economic rights?
 - Democracy?
 - Sovereignty or autonomy?
 - Relationship with humanitarian law
- Economic sanctions
 - Focus on the strictest
 - US only
 - OFAC, the Office of Foreign Assets Control

OFAC Sanctions

Countries

- Traditional
- Broad
- Mainly now: Cuba, Iran, North Korea, Russia (Crimea), Syria, Venezuela
- Mixed motives, often include HRts

Targeted

- "Smart"
- Mainly "blocking"
 - Often entry bans too
- Enabled by tech
- SDN List over 1000 pages
- Changes almost daily
- Many triggers





The Good: Rising Trends

- More triggers
 - Magnitsky & Global Magnitsky
 - Parts of numerous programs
- More designations
- More statutes
- New use of BIS Entity List for Uighurs
- Likely more coming: HK, Uighurs, Religious Freedom





Recent Examples

- Syria Caesar Act designations for atrocities, including Bashar & Asma al-Assad
- Nicaraguan National Police "for its role in serious human rights abuse"
- 2 Zimbabwe officials "for their role in human rights abuses related to political repression in Zimbabwe"
- The First Vice President of South Sudan "for his involvement in serious human rights abuse, including the disappearance and deaths of civilians"





The Bad

Due process issues

Effects on targets personally and families

Effects on population of target country

Effects on sending country's own population



UN HRC Special Rapporteur: "precipitating economic and humanitarian disasters, making ordinary people pawns and hostages thereof"

The Ugly

- "An unusual and extraordinary threat to the national security and foreign policy of the United States"
- A threat, not yet actualized
- ICC: "[A]n unacceptable attempt to interfere with the rule of law and the Court's judicial proceedings.... [A]lso represents an attack against the interests of victims of atrocity crimes...."
- Ben Ferencz: "Refusing to accept the rule of law"
